Do We Live in a Great Neighborhood or What?

We live in a great neighborhood. We all know it, and we don't need proof. But my wife and I were recipients of good deeds from three great neighbors, and we want to tell you about it.

We live at the corner of Mistletoe Avenue and Forest Park Boulevard. As you would expect, living on the "S" curve for the past 44 years has provided us opportunities to see many vehicles up close and personal. Cars have missed the curve, taken out trees and landed in our yard. On the night of February 1, another car went airborne and pushed over a 24-foot oak tree in our parkway.

On Sunday morning, neighbors Eric Rustad, John Key and Mateson Gutierrez showed up at our front door and told me they were ready to remove the fallen tree. They removed the branches and cut the trunk into pieces small enough to carry off in their two pickups. Historic Mistletoe Heights Book

Have you researched your house and its former owners at the public library?

How to Research the History of Your Home

Almost all of the early residents of Mistletoe Heights prove to be interesting or successful people because it was the newest, greatest neighborhood being developed in Fort Worth circa 1920. It was very desirable for affluent up and comers who wanted to move to this prestigious area of brand new brick homes.

You should be able to research your property and early owners by trying the following:

Early deed records may be found at: www.tarrantcounty.com. Go to the tab labeled "online services" and then "Deed History card search." Some of the subdivisions you can search for in Mistletoe Heights include: Mistletoe Heights, Jerome, Forest Park Place, Mistletoe Sangamo, Sangamo Park, and Frisco.

Basic information can also be found on Tarrant Appraisal District where Tarrant County Property records have been kept since about the 1980s. You should be able to find your specific subdivision name, block number, and lot number on TAD.

Once you find a name of an early owner, try a search using the owner's name or the business name associated with that person at <https://fortworthlibrary.lyrasistechnology.org/> and <http://www.fortworthtexasarchives.org/>.

You can try Internet searches of all key words, names and addresses. Sometimes adding the words "Fort Worth," "genealogy" or "history" to the key words helps narrow down results.

If you have a Fort Worth Library card with online access, you can search Fort Worth newspapers and other history online through their access to records. Phone or visit the downtown library and ask for help on how to get started.

A visit to the downtown Fort Worth Public Library asking for help in researching your property and the early people who lived there can be very helpful. They have the Sanborn Insurance Company Fire Maps, the Fort Worth City Directories and much more.

Also, you can try to search the Star-Telegram Photo Collection housed at UTA (<https://library.uta.edu/digitalgallery/collections/show/50>) and the Portal of Texas History (<https://texashistory.unt.edu/>).

Try Ancestry.com records – you can find census data, obituaries, birth and death dates, city directory info by year, and sometimes photos. With a name or two, you can usually find info there.

Is your house a designated Fort Worth landmark? If so, the city's Fort Worth Historic Preservation Office should have info on your house (<http://fortworthtexas.gov/planninganddevelopment/historic-preservation/>).

You can also check Historic Fort Worth's archives for info on your home. (<https://historicfortworth.org/resources/>) Sometimes they have a folder on historic homes. (Be sure to drop off a folder of your research on your home for them to archive after you have completed this project.) You can email your request to prc@historicfortworth.org or make an appointment and go there for help. The HFW archives also have the Sanborn Insurance Fire Maps.

Also, you can try to research the early families in your home by asking the Tarrant County Archives about specific names or key words. Try emailing LESpalding@tarrantcounty.com or archives@tarrantcounty.com. You can also visit the Tarrant County Archives. They too have the Sanborn Insurance Fire Maps. Mistletoe Heights is in the 1927 maps (don't look in 1926), Volume 4 and 1950 maps (Volume 5).

Good luck on your research! And please let us know if you find any more useful resources not listed here.
